
	<h2>Managing Your Forest for Timber and Wildlife! A Tree Farm Field Day!</h2> <p>Presented by Michigan Conservation Districts, Forestry Assistance Program, American Tree Farm System, and Lake States Forestry</p>

During this workshop you will learn about different factors to consider when making management decisions in your forested property. Specific topics will include defining your objectives, tree species and what they require, revenue from harvesting trees, wildlife habitat, diversity of species and structure, environmental quality, and invasive species. The field day will also introduce the American Tree Farm System (ATFS), a voluntary forest certification program for family forest owners. “Tree Farm” celebrated its 75<sup>th</sup> anniversary in 2016. The workshop will include an indoor presentation and a field tour of a property with different types of forest management and that is certified in ATFS and verified in Michigan Agriculture Environmental Assurance Program (MAEAP) Forest, Wetlands, and Habitat A\*Syst (FWH\*A\*Syst). Continuing Education credits through the Society of American Foresters (4.5 Category 1 Credits), as well as MAEAP Phase 1 Education Credit, will be available for those who attend.
